


How can an applicant share their forgiveness application with another authorized user?

Applicants can enable authorized users such as CPAs or Administrators to login and assist with completing their PPP forgiveness application.

Due to the complexity of the calculations required for some of the PPP forgiveness application forms, we have built in the ability for an applicant to share their application with another authorized user. Once shared, that authorized user can login and assist in completing the forgiveness application.


To "Share" their application, the applicant will need to click on the  icon:



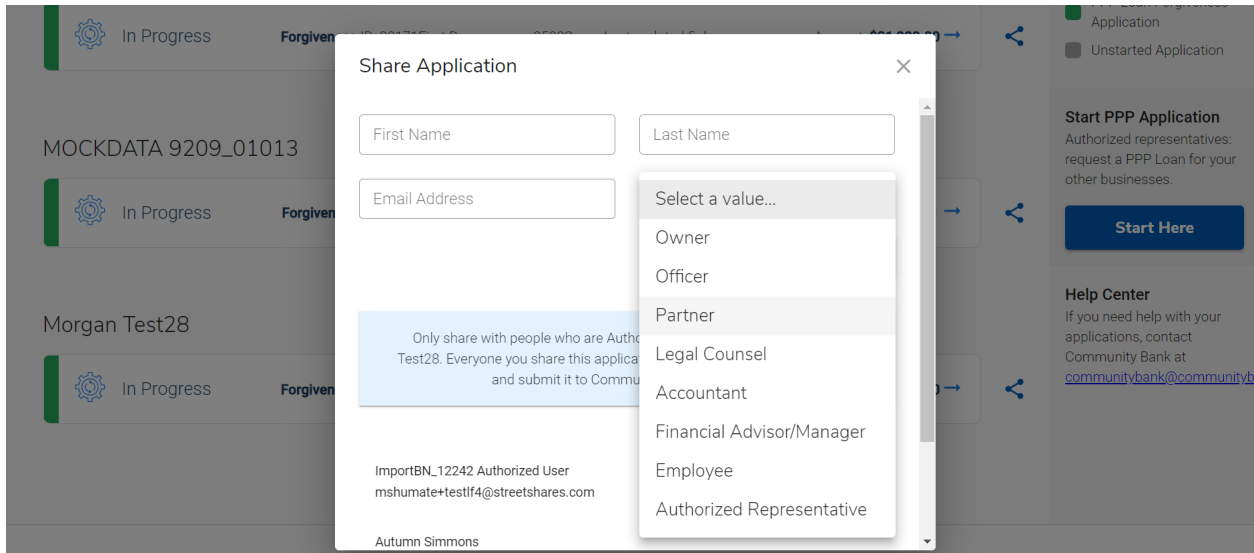

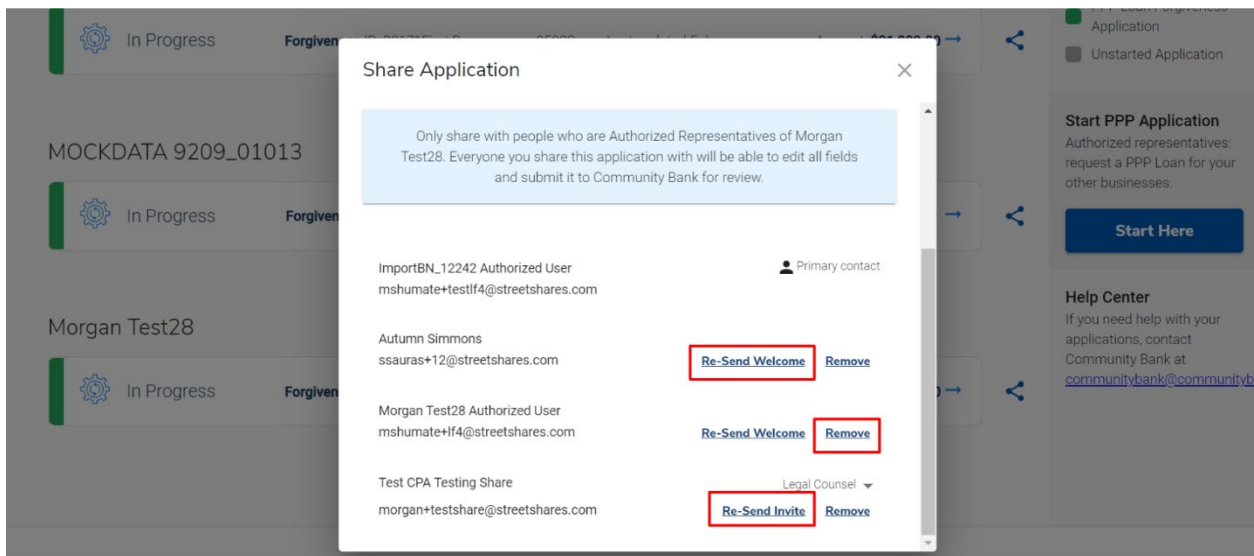

The applicant will need to fill in First Name, Last Name, Email Address, and Role for the authorized user they would like added to their forgiveness application. The roles that can be selected are shown below:



Once the applicant fills in the necessary fields and clicks the "Share" button, an Invitation Email will be sent to the email address provided. The applicant has the ability to "Re-send Invite" email, "Re-send Welcome" email, or "Remove" an authorized user directly through the "Share" icon in the borrower hub:



Once a designated authorized user receives their Invitation Email and successfully sets up their account, they can then login and make changes to the forgiveness application. Authorized users also have the ability to submit the forgiveness application for review, so it is important that applicants are only sharing their applications with trusted users.
